ed, we still need to follow Dr. Bonnie Henry's Provincial Health Orders. The Province is still working




continuously in their efforts to vaccinate B.C.

Bioenergy at Gitaus

We wanted to keep you informed...

The Kitselas Housing, Public Works and Infrastructure Department has been working with local consultants (Westland Resources) with support from the Pacific North Coast Development Society and the Skeena-Nass Centre for Innovation in Resource Economics Society to look into opportunities to produce bioenergy at Gitaus. This work started in 2018 and we are currently in the feasibility stage of the project, which means we are trying to determine if a project like this could be a good fit for the Kitselas community, from a social, economic, and environmental prospective.

The idea behind this project is to see if Kitselas could make use of a locally abundant resource – wood waste from logging operations in Kitselas Territory. This waste wood usually consists of branches and other parts of the tree that aren't used to produce lumber and are often burned at the logging block. We are seeing if Kitselas could use this material to make energy that would be used to heat or produce electricity for the community. The process of turning wood into energy also makes by-products, such as ash and char, and we are looking into opportunities to produce and make money off these byproducts as well. The project team has visited or met with representative from a number of facilities in BC that are using wood to produce energy and/or other products including: BC Biocarbon Facility, Advanced BioCarbon 3D, NRC Microgrid Testing and Training Facility, and Teslin Bioheat.

Based on your input into the Kitselas Community Land Use Plan and the Comprehensive Community Plan, it seems like members are open and excited about renewable energy opportunities and increasing community self sufficiency. Kitselas already has a strong history in the local forest industry and this project could build off that knowledge and experience.



FSC COMMUNAL HERRING LICENCE

DFO has issued Kitselas First Nation their 2021 Pacific Herring Food Fishing Licence for the purposes of harvesting spawn on kelp or boughs. In summary, the licence is:

- valid from March 1, 2021 to June 30, 2021
- for Pacific Management Areas 4-12, 4-15, 5-1 and 5-23 (maps also attached of these areas)
- for 4636 kilograms (total for all members)

Definitions

"Band" means the First Nation.

"Commercial Fishing Vessel" means a vessel that is registered according to the Pacific Fishery Regulations, 1993 and which is used to fish for a species of fish which is authorized by a commercial fishing licence (including commercial licences under the Aboriginal Communal Fishing Licences Regulations). This does not include non-licenced vessels fishing for food, social and ceremonial purposes.

"DFO" means Department of Fisheries and Oceans.

"First Nation" means First Nation noted as a licence holder in this licence.

"Fishery" means fishing under the authority of this licence.

"Indian Status Card" means a photo identity card issued by the Aboriginal Affairs and Northern Development Canada and entitled 'Certificate of Indian Status'.

"Management Area" means a management area as defined in the Pacific Fishery Management Area Regulations.

"Non Commercial Fishing Vessel" means a vessel that is not commercially licenced.

"Subarea" means a Subarea as defined in the Pacific Fishery Management Area Regulations.

Use of Fish

Fish caught under this licence are for food, social and ceremonial purposes. Without prejudice to future agreements or regulations, sale of Fish caught under this licence is not permitted.

Designation of Vessels

If the harvester is intending to use a commercial or non commercial fishing vessel to participate in the fishery the First Nation must designate the vessel in writing and notify the C&P Prince Rupert Detachment General Duty Supervisor (phone: 250-627-3401, fax; 250-627-3188, or email DFO.NCAP-PACN.MPO@dfo-mpo.gc.ca) at least 24 hours prior to using the vessel in the fishery. Vessel designations must set out the fishing times, areas, and gear authorized by this licence.


The vessel designation must be carried on the vessel at all times while the vessel is being used in the fishery or while transporting fish harvested in the fishery. Proof of vessel designation must be presented to any Fishery Officer or Fishery Guardian on request.

Designation of Individuals

The First Nation has designated all members of the First Nation who have a Band Indian Status Card for the licence holder noted in this licence to fish under this licence. Band Indian Status Cards are acceptable proof of designation. The Band Council may designate additional persons to fish under this licence by issuing to them a designation permit.

Prior to the fishery, the First Nation will provide the C&P Prince Rupert Detachment General Duty Supervisor (phone: 250-627-3401, fax: 250-627-3188, phone: 250-627-3428 or email DFO.NCAP-PACN.MPO@dfo-mpo.gc.ca) with a list

of the additional persons designated.

Designations are personal and non-transferable. Designation permits must contain details of this licence including the name of the designated participant, the species that may be caught, harvesting times, maximum quantities, fishing gear, fishing areas and reporting requirements.

A Band Indian Status Card for the licence holder in this licence or a designation card must be carried at all times by designated persons while participating in the fishery or while transporting fish harvested in the fishery. Proof of designation must be presented to any Fishery Officer or Fishery Guardian on request.

Transporting Harvest

The First Nation may designate persons to transport fish harvested under the authority of this licence. The Band Council will issue each person so designated with a transport permit that will contain:

- 1. The name of the person(s) transporting the fish,
- 2. The quantity and species to be transported,
- 3. The date of transport (departure and arrival),
- 4. The destination of the product,
- 5. The vehicle and vehicle licence plate number or the vessel name and the Vessel Registration Number (VRN) licence number or MOT number,
- 6. The names of the individuals receiving product, and the amounts thereof.

Before transporting under this licence commences, the First Nation will provide the C&P Prince Rupert Detachment General Duty Supervisor (phone: 250-627-3401, fax: 250-627-3188, or email DFO.NCAP-PACN.MPO@dfo-mpo.gc.ca) with a list of the persons designated to transport and their transport permit number.

Transport permits must be carried at all times by designated persons transporting product harvested in the fishery. Transport permits must be presented to any Fishery Officer or Fishery Guardian on request. Transport permits are personal and non-transferable.

Catch Monitoring and Harvest Reporting

Catch monitoring will be conducted by DFO and the First Nation. The First Nation will keep a record of all harvests under this licence. Where, during a week, harvesting of herring spawn on seaplants or boughs is carried out under this licence, the First Nation will provide to the DFO AFS Resource Manager at DFO.NCAP-PACN.MPO@dfo-mpo.gc.ca, or upon request by the C&P Prince Rupert Detachment, a copy of the up to date harvest log, on Wednesday of each week.

Compliance with the Fisheries Act

Pursuant to subsection 22(6) of the Fishery (General) Regulations, compliance with the Fisheries Act and the regulations made under the Act is a condition of this licence.





This year, Kitselas Lands and Resources (KLRD), Kitselas Employment and Training (KET) and Kitselas Five Tier LP. (K5T) are working together to expand this community-led program and bring two new educational opportunities to Kitselas citizens and other community members.

Curriculum on the oolichan (all welcome!)

We have ongoing land-based educational opportunities for anyone interested in learning more about the science and biology behind the oolichan.

We are working on a curriculum that will teach participants about this notorious little fish and its impact on our land's ecosystem.
