Re: Financial Distribution Update

The Kitselas Administration, has been working diligently with the Kitselas Members in receiving the first batch of applications of a total of 380 applicants; before the October 20^{th,} 2021 for processing payment date of November 2, 2021.

These applications have been processed, and those that have selected cheque form will be mailed out this week, and those that selected EFT(direct deposit) have also been processed; these are for those that submitted application before the highlighted date.

Note: Next Payment Schedule (allow 10 business days):

- 1) Applications received prior to October 20 will have a payment date of November 2, 2021.
- 2) Applications received prior to October 27 will have a payment date of November 9, 2021.
- 3) Applications received prior to November 10 will have a payment date of November 23, 2021.
- 4) Application received after November 10 will be processed within 10 business days.

Applications forms will be made available for download online at Kitselas.com or for pick up at our Administration Office and Queensway Office, during office hours, Monday to Friday 8:30 a.m. – 4:00 p.m. (Closed on statutory holidays).

Round 2, of the applications is now being reviewed and in the process for next payment schedule for November 9, 2021.

Kitselas Community,

We are still in the COVID-19 pandemic and 4th wave of the Delta variant.

The Northern Health Region in which we are located in, we are still in step 3 of B.C.'s plan.

Kitselas Emergency Management and Kitselas Health department continue to update new or updated Provincial Health Orders (PHO) to the community.

We kindly ask that you continue your efforts to stay safe, and do your part for yourself, your family, and your community

The Kitselas community has four active cases within Gitaus and Kulspai. They are in isolation and checking in with Northern Health and our Health Department. We are doing our part to help and assist our band members/community members in the best way we can.

Below are the guidelines set out by the Province.

Personal gatherings

All people ages 12 and older must be fully vaccinated.

- Indoor personal gatherings are limited to your household plus up to 5 visitors or one other household
 - Everyone must wear a mask or practice 2 meter physical distancing
- Outdoor gatherings are limited to your household, plus up to 25 people

People who are not fully vaccinated can only gather with their own household.

Organized gatherings

All people aged 12 and older must be fully vaccinated and show proof of full vaccination.

- Indoor events are limited to 50 people, and masks are required
- Outdoor events are limited to 100 people







Masks are required in all public indoor settings for all people born in 2016 or earlier (5+).

This includes:

- Malls, shopping centers
- · Grocery and liquor stores
- Airports
- Coffee shops
- On public transportation, in a taxi or ride-sharing vehicle
- Libraries
- Clothing and retail stores
- · Areas of office buildings where services to the public are provided
- Common areas of sport and fitness centers when not engaged in physical activity
- · Common areas of post-secondary institutions and non-profit organizations
- Inside schools, including all K to 12 students
- Drug stores
- Community centers
- · Recreation centers
- · City Halls
- · Restaurants, pubs and bars when not seated at a table

There are exemptions for:

- People with health conditions or with physical, cognitive or mental impairments who cannot wear one
- · People who cannot remove a mask on their own
- Children under the age of 5
- People who need to remove their masks to communicate due to another person's hearing impairment

A face shield is not a substitute for a mask as it has an opening below the mouth.







Symptoms of COVID-19 can vary from person to person. They may also vary in different age groups.

Symptoms may take up to 14 days to appear after exposure to COVID-19.

COVID-19 vaccines are all highly effective at preventing severe COVID-19 illness and death. However, vaccines are rarely 100% effective and you may still become infected with or without symptoms.

Some of the more commonly reported symptoms include:

- · new or worsening cough
- shortness of breath or difficulty breathing
- temperature equal to or more than 38°C
- feeling feverish
- chills
- fatigue or weakness
- muscle or body aches
- new loss of smell or taste
- headache
- abdominal pain, diarrhea and vomiting
- feeling very unwell

if you have been on contact with a positive case person, please monitor for symptoms and call 811 or your family doctor.

Internet Reminder: Graydon will no longer be provided, you will need to contact Lisa Graydon @ Telus, information provided below.

Internet for Good / 25Mbs for \$9.95/month

- Eligibility Families: Link
- Receive the maximum Child Care Benefit
- Can provide a recent Canada Child Benefit (CCB) statement showing your family net income of less than or equal to \$31,120
 - * Note: The Internet for Good account must be under the name of the individual named on page 1 of the CCB statement

Edibility People with Disabilities: Link

- Receive the PWD or AISH benefit
- Have proof of receipt of the PWD or AISH benefit, such as:
 - BC Ministry of Social Development and Poverty Reduction Confirmation of Assistance statement OR Release of Personal Information
 - CRA Statement of Canada Pension Plan Benefit T4A(P)

Eligibility Youth Aging out of Care: Link

- Have been in the child welfare system and can produce a letter of eligibility completed on your behalf by a ministry/agency representative
- Are between the age of majority (19 in BC) in the province in which you currently reside and 26 when you
 apply.
- Meet the below province-specific care requirements according to the province in which you were in care
- British Columbia: Were in permanent or temporary care of Ministry of Children and Family Development/Delegated Aboriginal Agency OR on a youth agreement as of their 19th birthday OR are eligible for the Agreement with Young Adults Program

Mobility for Good

- 3GB of shareable data at high-speed and endless data at reduced speed
- Unlimited Canada wide talk & text

Eligibility Seniors (\$25/month): Link

- Receive the GIS benefit
- Can provide your Old Age Security statement, also known as the T4A(OAS), indicating an amount paid to you in box 21 (net supplements paid)
- Eligibility Youth Aging out of Care (\$0/ month plan for two years & Free Phone) Link
- Have lived experience in the child welfare system and can produce a letter of eligibility completed on your behalf by a ministry/agency representative
- Are between the age of majority (19 in BC) in the province where you currently reside and age 26 at the time of your application
- Were in permanent or temporary care of Ministry of Children and Family Development/Delegated Aboriginal Agency OR on a youth agreement as of your 19th birthday OR are eligible for the Agreement with Young Adults Program








Power Engineering Readiness

- On reserve Kitselas members
- Off reserve Kitselas members

Responsibilities

- 1. Prepare for meetings by reviewing all materials prior to meetings.
- z. Attend an estimated THREE (3) scheduled meetings Zoom will be available for meetings
- Provide feedback and advice to the Director and fully participate in discussions of matters related to Kitselas potential Treaty Settlement Lands.
- Review and comment on materials circulated via email or mail as per applicable forms and documentation provided by the Director or delegate.

What is the Kitselas Marine Plan?

It is a strategic document to guide marine resource management in Kitselas marine Territory.

Why does it need to be updated?

The current plan was drafted in 2010. As with any plan, it is best practice to update as we learn, and as the context we are working in changes over time. There is also a need to fill gaps in the current plan.

How will it be updated?

KLRD and other Kitselas Admin staff will be updating the plan based on community wants and needs. So we need your input! We are currently planning opportunities for community engagement, an initial engagement in Winter 2021 and more fulsome engagement of the draft updated plan in 2022. More opportunities for engagement will be considered as the project progresses.


