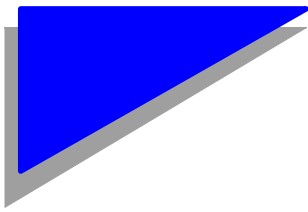
Our Independent Review Responsibility
