- K5T General Update
 - There is one other major pressing item. K5T has the opportunity to invest a significant amount of money over the next 10 days. I have come up with a strategy to maximize the benefit to Kitselas inline with the funding agreement. We have options, choices and back up plans for the spending. The best option is to create a new corporation under KSDEC with a proposed starting name of "Kitselas Foods". K5T can champion drafting the corporate documents in partnership with Ashcroft, we can execute with your permission, and meet the deadline of March 31st, 2023.
 - The money will be invested in infrastructure at the Clubhouse to produce food for SPF program participants. We can either buy the food at the grocery store or we can produce it ourselves. If we produce it

ourselves we gain the space and equipment to produce the food. This concept is our best effort to build equity to serve our participants effectively while gaining equity maximum for Kitselas through KSEDC, K5T, KCL and the proposed new Kistelas Foods Corp. (The KSEDC portfolio is a demonstration of a circular economy 100% owned by Kitselas serving everyone's best interest, that our funding partners are looking to invest in. This model has eyes on it across the country and will succeed with your support. We are trail blazing something that will certainly be duplicated and influence how employment programming is delivered going forward across the country. Let's celebrate together March 30th at the Terrace Sportsplex.
